  - By registering through a domestic company who acts as a commercial agent;

- 3. Local bidders should submit renewed license, VAT registration, TIN certificate and current year tax clearance.
- 4. International bidders are required to submit an authorized license or certificate that certifies the bidder to transact the subject matter of the bid from the country of origin.
- 5. The bid must be accompanied with a minimum bid security amount of ETH Birr 2% of the total bid amount or its equivalent in USD in one of the following forms:
  - a) CPO
  - b) Bank guarantee
  - c) Bid Bond issued by a well-known foreign bank and confirmed through a recognized domestic bank in Ethiopia and the bidder should inform BIC by fax or e-mail to collect the bid bond before the closing date.

The bid remains floating from <u>February 26, 2023</u> to <u>March 28, 2023</u> and will be closed on <u>March 28, 2023</u> at 4:00 PM and opened in the presence of bidders or their representative on the same date at 4:30 PM at the Company's Meeting room, Basement Floor Fitawrari Damtew Avenue, Behind AU Bunna Insurance Building. Bids presented by any bidder after the closing date and time shall not be accepted.
